2 The Secretary of Education shall promulgate, after
3 consultation with public safety organizations (which shall
4 include firefighter and emergency responder organiza5 tions), regulations to carry out the amendments made by
6 section 2, including regulations relating to—

7 (1) the minimum volunteer time required for a
8 qualified volunteer firefighter and qualified volunteer
9 emergency medical technician to be treated as an in10 dividual employed in a full-time job for purposes of
11 section 455(m) of the Higher Education Act of 1965
12 (20 U.S.C. 1087e(m)); and

13 (2) the process of tracking and verifying that14 volunteer time.
